

2nd ANNUAL ARTISANS MARKET ON THE SQUARE
at Beanfest
Mountain View, Arkansas
October 30 & 31, 2009

The 27th Annual Bean Fest and Championship Outhouse Races will be held on October 30 and 31, 2009. The Mountain View Area Artisans Council will host the 2nd Annual Artisans Market on the Square at Beanfest featuring hand made fine and contemporary art and craft, heritage arts, and folk art. The Artisans Market will be located on Peabody Street on the east side of the Stone County Courthouse. Musicians will be performing on the courthouse lawn. Bean pots will be cooking on the west side of the square and, of course, the Outhouse Races will be on Saturday. The Mountain View Area Artisans Council includes the Arkansas Craft Guild, the Mountain View Art Guild, the Off the Beaten Path Studio Tour, the Ozark Folk Center and the Ozark Folk Fiber Guild.

GUIDELINES FOR THE MARKET:

Because of limited space for no more than 40 booths, this event is open to artists who produce hand made work, are in the Mountain View area (with an approximate radius of 35 miles of Mountain View) and others by special invitation. All work must meet the following standards:

1. Entries should be original or traditional designs and made by the artist.
2. All work displayed for sale must be in the medium/media submitted to and accepted by the Artisans Market Committee. All displays will be reviewed by representatives of the Committee throughout the show to ensure compliance with the rules. It is the committee's right and responsibility to remove work that does not meet the rules of the event. Non-compliance with rules may result in expulsion and/or ineligibility to participate in future shows.
3. Members of the Arkansas Craft Guild, the Mountain View Art Guild, the Off the Beaten Path Studio Tour, the Ozark Folk Fiber Guild and craft demonstrators from the Ozark Folk Center are not required to submit to the jury process, but must complete the application and are subject to committee review.
4. Artisans not a member of the listed organizations are required to submit 4 digital photographs of their work and one digital photograph of their booth. All images are to be submitted in JPG format at a resolution of no less than 800 x 600 at 72 dpi. Larger images are preferred. CDs (non-returnable) are preferred, the submissions can be presented on the artisans website or via email. All images must be labeled with last name and image number. For instance, hoefer01.jpg, or larsen05.jpg. Also label submitted CDs with a Sharpie marker. If you have any questions about image submission please contact Shawn Hoefer at shawnhoefer@gmail.com.
5. Dates for the Market:
 - July 30, 2009 - Deadline for priority consideration to Mountain View Area artisans. After this date, all unassigned booths will be open to participants from across the state and beyond.
 - September 15, 2009 - Deadline for registration**
 - October 1, 2009 - Booth assignments and directions will be sent by email
 - Set-up time: Friday, October 30, 7:00 - 10:00 AM. To prevent crowding, please unload vehicles and remove them from site as soon as possible. All vehicles must be out of the area no later than Friday at 10:00 AM.
 - Show dates/hours:
 - Friday, October 30, 2009 11:00 AM to 5:00 PM, Saturday, October 31, 2009 9:00 AM to 4:00 PM
 - Artisans are welcome to open earlier and stay later*
 - Vehicles will not be allowed into the market area until 4:00 PM on Saturday. Artisans are required to stay until 4:00 PM on Saturday.
6. Overnight security will be provided by the Mountain View Police and Stone County Sheriff.
